- Permanent Government Officer (BS-17 and above) nominated by respective Federal/ Provincial Government
- Minimum 2 years of experience in relevant field.
- Regarding PhD Program (Preferably) 3 years experience after graduation from KOICA master's degree program.
- Be in good health, both physically and mentally.
- Applicants must have a strong command of English, both in speaking and writing. Proficiency in English is required to attend classes conducted entirely in English and to be able to write academic reports and thesis in English.
- Bachelor Degree or an equivalent to College/University level Educational background for Master's Degree Programmes.
- Applicants who apply to the KOICA Doctoral degree Program must be the KOICA fellows who have successfully completed the KOICA master's Degree Program. (Other detail available in each specific course document uploaded)


