Eligibility Criteria.

- Preferably be a government Officer (BS-17 or above).
- Be a suitable young scholar/student in relevant subject of education with a good academic record;
- Be in good health to undertake the Programme;
- Have proficiency in spoken and written English language.

Required Documents:-

- Education Qualifications-Degree (Certificates and Mark Sheets);
- Proof of Nationality-Passport;
- Curriculum Vita;
- Statement of Purpose (800 – 1000 words);
- Two Letter of Reference;
- If employed, a Relieving Certificate from your employer;
- Proof of language Proficiency;
- Photo (Passport size).

2. All interested Officers who fulfill the eligibility criteria are required to forward their nomination alongwith FTC Proforma, copy of CNIC & CV duly recommended by the Head of respective Wing to **QA-I Section latest by 18.8.2023.**

Note:- "In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous government service or less than three months of service in Finance Division or against whom disciplinary proceedings/inquiry is in progress or on probation period, may need not apply"
