Interested Officers, who fulfill the eligibility criteria, are requested to furnish their nominations in the form of applications for the respective training programme, duly recommended by the concerned AFS/head of the wing concerned along with FTC Proforma and copy of CNIC to QA-I Section as per due date. After approval from FTC the nominee will apply online at <http://tiea-thaigov.mfa.go.th>.

Note:- "In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous government service or less than three months of service in Finance Division or against whom disciplinary proceedings/inquiry is in progress, may need not apply".
