- ii. Minimum 2 year of experience in the relevant field.
- iii. Be under 40 year of age on 7<sup>th</sup> April, 2023. (Preferably).
- iv. Be in good health, both physically and mentally.
- v. Bachelor Degree or an equivalent to College/University level Educational background for Master Degree Programmes.
- vi. Master Degree or an equivalent to College /University level Educational background for Doctoral Degree Programmes.
- vii. English Language Proficiency proof / English Language Test score as per attached course document.
- viii. Not be a person who has withdrawn from KOICA's scholarship Program before. (Other detail available in each specific course document uploaded).
