- 2. The amount of contribution shall not be included in the emoluments of the officers concerned for calculation of income tax and deduction of the recovery of the House Rent Charges.
- 5. All proceeds received in the name of the Fund will be credited to the public accounts of the Federal Government under following head of account:

G12 - Special Deposit Funds

G121 - Relief Fund

G12166 - Prime Minister's Relief Fund for Turkiye and Syria earthquake victims
