


TENDER NOTICE



TERMS & CONDITIONS OF TENDER

The terms and conditions of the tender for purchase of office stationary, computer accessories, machinery and equipments and miscellaneous items by the Finance Division are as below: -

1. Tender should accompany a Pay Order/Bank Draft of **Rs.100,000/- (Rupees one hundred thousand only)** in favour of DDO of Finance Division as Earnest Money failing which the offer will be rejected. The earnest money will be returned to the unsuccessful bidders immediately after finalization of the tender and in case of successful bidder(s), it will be converted into Security Deposit which will be retained till **30-06-2015**.
2. Rates to be quoted shall be inclusive of GST and all taxes and will be valid upto **30-06-2015**. However, the procuring agency may extend contract period beyond 30-6-2015 till finalization of next tender.
3. Samples of the items, where possible, especially for papers should be attached with the tender without which the offer will not be entertained.
4. The firms shall be liable to supply the requisite items at "Q"-Block, Pak Secretariat, Islamabad at their own expenses and even at short notice if needed failing which the security deposit of the firm will be forfeited and the firms will be blacklisted.
5. Authorized Dealership Certificate from the manufacturers/ Principal Suppliers shall have to be provided, in case of toners. If during the currency of the period it is found that sub-standard items or in-genuine toners/cartridges are supplied, the contract will be cancelled and Security Deposit will be forfeited and the firm will also be blacklisted.
6. The Firms must have and provide Sales Tax Registration Certificate, National Tax Number and vender No. as well as facilities of telephone /fax lines.
7. An affidavit to the effect that the firm has never been indulged in any litigation and has never been blacklisted by any Ministry/Division/ Department/Organization of the Government(s) must be attached with the bids.
8. Submission of any false statement/documents and concealing of information is likely to disqualify the bidder.
