Age relaxation will be given as per rules to following categories as indicated against each:

1	(a) Candidates belonging to Balochistan for posts in BPS 15 and below under the Federal Government.	3 years.
2	Released or Retired Officers / personnels of the Armed Forces of Pakistan.	(15) years or the number of years actually served in the Armed Forces of Pakistan, whichever is less.
3	Government servants who have completed 2 years continuous Government service on the closing date for receipt of applications.	10 years, upto the age of 55 years.
4	Disabled persons for appointment to posts in BPS 15 and below.	10 years.
5	Widow, son or daughter of a deceased civil servant who dies during service.	05 years.

How to Apply:

Interested eligible candidates shall register themselves with National Testing Service (NTS) as per following procedure:-

- * Application form is available at NTS website www.nts.org.pk.
- * Take printout of form.
- * Send application form to NTS Headquarters, # 96, Street No.4, Sector H-8/1, Islamabad not later than 15 days of publication of this advertisement.
- * Candidates already in Government Service shall require to apply through proper channel after qualifying written tests.
- * Candidates belonging to Balochistan (under Aghaz-e-Haqooq-e-Balochistan) are exempted from test fee.
- * NTS/National Savings will not be responsible for late receipt of applications sent through post. Applications submitted in person will not be entertained. Applications sent directly to National Savings in contravention of the prescribed procedure will not be entertained.
- * Admit cards to the candidates will be sent by NTS at postal address of the candidates to appear for the written test, to be held as per date given by NTS on their website, in the major cities of country.
- * Only eligible candidate will be provisionally allowed to appear in written test, however, if any candidate is found ineligible he/she will be disqualified at any stage of the recruitment process.
- * On the basis of merit only short listed candidates will be called for the interview.

Last date for receipt of applications is 15 days from the date of publication.

IMPORTANT INSTRUCTIONS:

Concealing of facts and any direct or indirect pressure for appointment would lead to the disqualification of candidate.

Note:- No TA/DA will be admissible to the candidates for appearing in test / interview.
