Subject:- **CALL FOR NOMINATION FOR FOREIGN TRAINING PROGRAMS AT MALAYSIA**



<ul style="list-style-type: none"><li>➤ Be Government Officer(BS-17 and above) only and nominated by respective Federal Government.</li><li>➤ Auditor or Assistant Auditor</li><li>➤ Age between 26 to 50 years old( Middle or Senior level)</li><li>➤ At least five(5) years of government auditing experience in Public Sector preferably in Performance Auditing or planning to initiate such audit in near future.</li><li>➤ Have good command of spoken and written English</li><li>➤ Medically fit</li><li>➤ Members of Supreme Audit Institution,(SAI)</li></ul>	<ul style="list-style-type: none"><li>➤ Be Government Officer(BS-17 and above) only and nominated by respective Federal Government.</li><li>➤ Have at least three(3) years of working experience in Real Estate =valuation or related field.</li><li>➤ Possess a basic university degree in real estate valuation</li><li>➤ Have good command of spoken and written English</li><li>➤ Age between 26 to 45 years old( Middle or Senior level)</li><li>➤ Have never participated in any MTCP organized by other training institutions in Malaysia.</li></ul>

**Note:-** "In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous government service or less than three months of service in Finance Division or against whom disciplinary proceedings/inquiry is in progress, may need not to apply"
