Interested officers of Finance Division, who fulfill the given eligibility criteria, are requested to furnish their nominations duly recommended by the AFS/head of the wing concerned alongwith FTC Proforma by **16-04-2018**. Eligibility Criteria:

- I. Officers (BPS-17 & above / Permanent only) of Ministries/Divisions/Attached Departments (at least 3 years work experience) most relevant to the training programmes.
- II. Copy of valid Passport.
- III. Applicants must hold a bachelor's degree or equivalent qualification.
- IV. Be in good health and free from any infectious disease with health certificate.
- V. Maximum age limit 45 years
- VI. Proficiency in English equivalent to IELTS 6.0 or TOFEL (IBT) 80 and above level
- VII. Consent / NOC of the department concerned.
- VIII. Contract Employees are not eligible.

Two-years Program (1+1 Studies)

- ix. Scholarship for the first academic year is the same as One-year Program. In the second academic year, students will do their thesis back in their home countries and the dissertation defense in China, while the scholarship will only cover one round-trip ticket for dissertation defense.

Note:- "In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous government service or less than three months of service in Finance Division or against whom disciplinary proceedings/inquiry is in progress, may need not to apply"
