In other foreign countries, contributions will be received at Pakistan missions and remitted to the State Bank of Pakistan which would prescribe necessary procedure for its accounting.

4. All proceeds received in the name of the Fund will be credited to the public account of the Federal Government under following head of account:

Accounts of the Fund will be maintained by Accountant General of Pakistan Revenues Islamabad and Fund will be administered by the National Disaster Management Authority (NDMA) in consultation with Finance Division.
