SUBJECT: ESTABLISHMENT OF PRIME MINISTER'S AUSTERITY FUND, 2026

It has been decided to establish/ open with immediate effect a Fund to be known as '**PRIME MINISTER'S AUSTERITY FUND, 2026**' to mitigate the impact of extraordinary spike in diesel and petrol prices due to war in the Gulf region.

2. All proceeds on account of '**PRIME MINISTER'S AUSTERITY FUND, 2026**' and payment into the aforesaid fund will be received at all branches of State Bank of Pakistan, all treasuries and branches of National Bank of Pakistan and all other Scheduled Banks.

3. The Fund may receive donations from both domestic, international donors and contributions from abroad which will be received at all the branches of above referred banks where such branches are existing. In other foreign countries, contributions will be received at Pakistan missions and remitted to the State Bank of Pakistan which would prescribe necessary procedure for its accounting.
