#### JOB DESCRIPTION

# For the post of Food Security/Agriculture Minister (BS-20) in the Embassy of Pakistan, Rome, Italy, under Ministry of National Food Security and Research

The job description for the post is as under:-

- 1. Food Security/Agriculture Minister, Embassy of Pakistan, Rome, Italy, acts as the alternate permanent Representative of Pakistan to the FAO of the UN.
- 2. He is therefore, required to liaise between FAO, other international bodies, with headquarters in Rome, like International Fund for Agriculture Development (IFAD), World Food Council (WFC) and Government of Pakistan.
- 3. The Officer is required to watch Pakistan's interests in these organizations and liaise with missions of friendly countries, located in Rome, for this purpose.
- 4. The officer would participate and represent Pakistan in the meetings/conferences of these organizations and their branches in accordance with the Government's laid down policy guidelines. He/She would promptly submit report of such events to M/o NFS&R and other stakeholders.
- 5. Should always have updated knowledge of Pakistan's development policies in general, and policies related to Agriculture, Food Security and Research in particular. He should be able to put eloquently and convincingly Pakistan's policies on the subject, with diplomatic fitness.
- 6. He must maintain good relations with the sources of important information and share all important information with the relevant stakeholders in Pakistan on timely basis.
- 7. Submit quarterly reports to this Ministry, on a regular basis, on the developments at the multilateral and plurilateral level in the field of Agriculture, Food Security and Livestock and the role/performance of his office in this regard.
- 8. He will analyze the decisions that are taken in the international bodies in agriculture, food security, rural development and related fields and keep the Government apprised suggesting specific course of action, wherever required.

#### **ELIGIBILITY CRITERIA**

For the post of Food Security/Agriculture Minister (BS-20) in the Embassy of Pakistan, Rome, Italy, under Ministry of National Food Security and Research

#### **Eligibility Criteria**

All Government officers of BS-20.

#### Education

PhD in agriculture or an agriculture related subject.

#### **Experience**

Relevant practical/academic experience of working in Pakistan. Knowledge of WTO related agriculture issues will be given extra weightage.

#### Age Limit

Upper age limit 56 years

#### General conditions for ineligibility.

- a. Officers against whom there is a disciplinary proceedings
- b. Officers from higher or lower grades.
- c. Officers who lack overall good record of service particularly during the last five years of service.
- d. Officers within promotion zone within the next 2 years.
- e. Officers who are applying for the 2<sup>nd</sup> tenure of foreign posting in their entire service with less than three years of intervening period between their first and the second foreign posting.
