

As you are aware that the Pakistan Institute for Parliamentary Services (PIPS), established under an Act of Parliament, is a first of its kind and exclusive research, training and capacity building facility for Members of the Parliament and their functionaries. In accordance with the statutory mandate, the Institute conducts specialized training programs for government officers as well, to enhance their understanding of the working of the legislature, its constitutional role, responsibilities and its relationship with the executive.

In pursuance of this mandate, PIPS plans to organize a series of thematic training workshops on Parliamentary Business for the officers serving in the Ministries/Divisions and their attached Departments, who will receive training on turn-basis over a period of six months.
