**SUBJECT: - TRAINING COURSE ON INTRODUCTION TO CLEAN ENERGY TRANSITION TOWARDS NET ZERO TARGET TO BE CONDUCTED IN PERSON IN SINGAPORE FROM 18 TO 22 AUGUST 2025 UNDER THE JAPAN SINGAPORE PARTNERSHIP PROGRAMME FOR THE 21<sup>ST</sup> CENTURY JSPP21**

The Economic Affairs Division vide its O.M No.4(21) SEA/SINGAPORE/2025 dated 30<sup>th</sup> April, 2025 has informed that the Government of Singapore and Japan have invited nominations for the above **(Fully Funded)** training course. **Eligibility Criteria:**

- Be Permanent Government employee (BS-17 and above) of this Division.
- Mid-to-Senior level government officials who are involved in policymaking for sustainability and clean energy solutions;
- Proficient in written and spoken English; and
- In good health.

**Objective:**

This course seeks to provide an overview of renewable and low carbon energy technologies, with a focus on the use of hydrogen and waste-derived renewable fuels as green fuels. Participants will also learn more about Singapore and Japan's approaches towards research and adoption of green fuels.

**Note:-** "In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous government service or less than three months of service in Finance Division or against whom disciplinary proceedings/inquiry is in progress, may need not apply".
