- Agricultural Mechanization Strategies: Machine Manufacturing, Government Support and Schemes, Economics and Marketing.

Eligibility Criteria:-

- Have Bachelor's degree in Agricultural Sciences/Engineering or its equivalent, with a considerable working experience in planning and executing the programmes related to the subject of the programme;
- · Be subject specialist or related to the subject of the programme
- · Have proficiency in spoken and written English language as the medium of conducting the programmes will be English only;
- Preferably under the 50 years of age with no participation in any AARDO offline training programme over the preceding two years; and,..
- Be in good health both physically and mentally to undergo the course of training.

All interested Officers who fulfill the eligibility criteria are required to forward their nomination alongwith FTC Proforma, copy of CNIC & CV duly recommended by the head of respective Wing to QA-I Section latest by 23.10.2023.
