- Suggest a model of an ecosystem-based strategy that focuses on long-term prevention of pests or their damage through a combination of techniques.


### **Eligibility Criteria:-**

The candidate must:

- Be a Government Officer (BPS-17 or above) or middle or senior level executives from Ministries/Divisions/Attached Departments, Provincial Governments and Public-Sector Universities.
- Have Bachelor’s degree with a considerable working experience in planning and executing Programmes.
- Be subject specialist and related to the Programme.
- Have proficiency in spoken and written English language as the medium of conducting the programmes will be English only.
- Be conversant with ICT, willing to undertake online training programme and have Zoom account/ID and other related technical requirements.

All Officers of Finance Division, who fulfilling the eligibility criteria are required to submit online application on AARDO’s website ([www.aardo.org/formDD.php](http://www.aardo.org/formDD.php)). Duly recommended by the head of respective Wing alongwith FTC Proforma & a copy of CNIC to QA-I Section latest by 7.11.2022.

*Note:- “In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous government service or less than three months of service in Finance Division or against whom disciplinary proceedings/inquiry is in progress or on probation period, may need not to apply”*
