SUBJECT: - TRAINING COURSE ON FOSTERING THE DIGITAL ECONOMY THROUGH AI AND DATA GOVERNANCE TO BE CONDUCTED IN PERSON IN SINGAPORE FROM 2nd – 6th FEBRUARY, 2026 UNDER THE JAPAN SINGAPORE PARTNERSHIP FOR THE 21ST CENTURY JSPP21

The Economic Affairs Division vide its O.M No.4(53) SEA/SINGAPORE/2025 dated 20th October, 2025 has informed that the Government of Singapore and Japan have invited nominations for the above **(Fully Funded)** training course. 2. The eligibility criteria and objectives of the subject course are as under:

Eligibility Criteria:

- Be Permanent Government employee (BS-17 and above) of this Division.
- Mid-to-Senior level government officials involved in urban development projects;
- Proficient in written and spoken English; and
- In good health.

Objective:

This course is conducted under the auspices of the Japan-Singapore Partnership Programme for the 21st Century (JSPP21). The course will explore the opportunities and challenges arising from artificial intelligence (AI) and big data in the digital economy. It aims to equip government officials with an innovative mindset to develop effective AI and data governance frameworks that protect privacy and intellectual property while maximizing economic benefits.

Note:- "In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous government service or less than three months of service in Finance Division or against whom disciplinary proceedings/inquiry is in progress, may need not apply".
