Subject: - **E-LEARNING COURSE "ON ASSOCIATE QUALIFICATION IN ISLAMIC FINANCE (AQIF) TO BE HELD FROM 21 25 MARCH, 2022 UNDER THE MALAYSIAN TECHNICAL COOPERATION PROGRAMME (MTCP).**

The Economic Affairs Division vide its O.M No.3(5)SEA/Malaysia/2022 dated 18-02-2022 has invited two (02) nominations of suitable Officers (BS-17 & above) for the above (fully funded) training course offered by Government of Malaysia through Malaysian Technical Cooperation Programme (MTCP). Eligibility Criteria:

- Be Government Officers (BS-17 & above) and nominated by their respective Federal and Provincial Government.
- General Certificate of Education (GCE) O-Level or equivalent with at least 1-year minimum experience in Financial/Banking services industry.
- Good command of English-written and spoken.
- High-speed internet access with speed requirement at least 1.5 Mbps: and
- An appropriate device including audio video capacity (Computer or Laptop and Smartphone or high-end table).

Objectives:

- Explain the meaning of Shariah, its objectives and sources
- Describe and identify the applications of Islamic finance transaction
- Identify the principles of ethics
- Identify the implementation of ethical values in Islamic finance and
- Discuss the challenges on implementing Shariah governance.
