SUBJECT: - **TRAINING COURSE ON INTEGRATED URBAN TRANSPORT SYSTEMS TO BE CONDUCTED IN PERSON IN SINGAPORE FROM 20 TO 24 APRIL 2026 UNDER THE SINGAPORE COOPERATION PROGRAMME TRAINING AWARD (SCPTA)**

2. **Eligibility Criteria:**

- Be Permanent Government employee (BS-17 and above) of Finance Division.
- Mid-to-Senior level government officials involved in managing sustainable transport systems, public transport policy and planning;
- Proficient in written and spoken English;
- In good health; and
- Prepared to participate actively in the program.

Objective:

This course will provide insights into how Singapore employs sustainable urban transport planning strategies and innovations to develop and manage our land transport systems effectively in environmental, financial and social aspects.

Note:- "In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous government service or less than three months of service in Finance Division or against whom disciplinary proceedings/inquiry is in progress, may need not apply".
