Eligibility Criteria:-

- Be Government Officer (BS-17 or above)
- Have bachelor's degree with a minimum three year's working experience in the concerned fields;
- Have proficiency in spoken and written English as the medium of conducting the programmes will be English only ; and ,
- Be conversant with ICT and willing to undertake online training programme.

All interested Officers who fulfill the eligibility criteria are required to forward their nomination alongwith FTC Proforma, copy of CNIC & CV duly recommended by the Head of respective Wing to **QA-I Section by 30.10.2024**. After approval from FTC the applicant will submit online application on AARDO's website (<http://aardo.org/formDD.php>).

Note:- "In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous government service or less than three months of service in Finance Division or against whom disciplinary proceedings/inquiry is in progress, may need not to apply"
